- 2. The CLIENT hereby engages the CONTRACTOR to prepare a home study and the CONTRACTOR agrees to prepare a home study for the CLIENT.
- 3. For and in consideration of the services to be provided by the CONTRACTOR to the CLIENT hereunder, the CLIENT hereby agrees to pay to the CONTRACTOR the following fees:
 - a. Application Fee of \$250.00

This fee is for initial review and determination of preparation suitability as well as opening a new case file, processing application and accompanying materials. Due with application.

b. Home Study Preparation Fee of \$4,100.00

This fee is for visits, interviews and associated communications and preparation of the report. This fee does not cover the cost of mileage for a World Links representative to visit your home, which will be billed at the state rate. Due with signed agreement.

c. <u>Document Expertise Fee of \$650</u>

This fee is for securing references, performing background checks, including FBI clearances and child abuse clearances, contacting employers, references, insurers and other involved entities and evaluating the information received as well as producing the required notices and requests to the information-giving entities. Due with signed agreement.

d. Post Adoption Report Preparation Fee of \$450 per report.

This fee covers the cost of preparation of 1 (one) Post Adoption Report with your visit to the World Links' office. This fee does not cover the cost of mileage for a World Links representative to visit your home, which will be billed at the state rate. You are required to submit a deposit for 4 (four) Post Adoption Reports upon completion of your home study.

e. Case Linking Fee
