Identification of a child for adoption and arrange adoption.	The Adoption Authority of the Kyrgyz Republic . Chinara Abdyldeaeva (Foreign Supervised Provider -FSP)
Securing of the necessary consent to termination of parental rights and to adoption.	The Adoption Authority in the Kyrgyz Republic is responsible for ensuring the parental rights have been terminated. The legal consents are an essential process for ensuring a child's eligibility and ensuring the ethics of an inter country adoption. The Adoption Authority in the Kyrgyz Republic is responsible for ensuring that the proper abandonment, relinquishment, or termination of parental rights procedures have been completed in accordance with both foreign law and proper ethical standards prior to a referral being made to the family. World Links will review documents, as permitted.

The home study will comply in all respects with the requirements of both US and foreign law and regulations. The home study will be provided to USCIS and no referral of a child for adoptive placement shall be formalized until USCIS has approved the family for the adoption of a child from the Kyrgyz Republic.</p> <p>The Adoption Authority of the Kyrgyz Republic is responsible for providing child's background study. The child's background study will include the reason the child is in care, social background, available family history, medical background, developmental history, photos. World Links will receive the child background study from the The Adoption Authority of the Kyrgyz Republic and provide it to the family.</p>

Making a non-judicial determination of the best interests of a child and the appropriateness of an adoptive placement for the child.	The Adoption Authority of the Kyrgyz Republic shall make a non-judicial determination of the best interests of a child and the appropriateness of an adoptive placement for the child. Adoption Authority of the Kyrgyz Republic shall identify a child for adoptive placement, in conjunction with the standards and procedures set forth by the country of origin and the USA Department of State. Such identification shall include a determination that the adoptive placement would be in the child's best interests taking all relevant factors into account including but not limited to the recommendation and approval of the family in the home study, USCIS, and by the Adoption Service Provider (ASP) World Links.
Monitoring a case after a child has been placed with prospective adoptive parents until final adoption.	N/A. Adoption is finalized in Kyrgyz Republic. Child cannot be placed before the finalization of adoption.
When necessary because of a disruption before final adoption, assuming custody and providing (including the facilitation the provision of) child care or any other social service pending alternative placement.
